## BACKGROUND

- Diageo decide to cease production at St. Francis Abbey brewery Kilkenny City in .
- 300 year history since 1710 (John Smithwick)
- Brewery had a major economic, social & physical impact on the City and County.
- Significant employer in the City for many years.







# Kilkenny Beople

St Francis Abbey Brewery to close in December 2013 (12 Jan 2012)

Profitable brewery closed (19 Jan 2012)

# **THE IRISH TIMES**

Smithwick site offers massive potential for city Feb 10, 2014

Decision to close seen as both loss and opportunity May 10, 2008, "Councillor Michael Lanigan (FF) said the company should give the site to the people of Kilkenny."



## TIMELINE

- Closure officially announced Jan 2012
- Local Authority agreed to purchase in May 2012 4.41 Ha (10.9 acre) site from Diageo for € 2.1 M
- Objective 3C of the Kilkenny City & Environs Development Plan 2014-2020
- "To prepare a master plan and urban design framework for the Smithwick's site and Bateman Quay during the lifetime of the development plan".
- Site handover to KCC November 2016.








Planning Dept took the initiative

  - Masterplan approved in July 2015.




### **Revisioned Masterplan – May 2015**






## Masterplan - Urban Design Strategy URBAN GRAIN

#### The Masterplan committed to :


- Extending existing street pattern & scale by

Commercial Advice



#### The Land Use Mix

- minimum residential component
- strong community of residents
- Relatively large no. of small and medium size business
- enliven the mixed-use frontages
- support other uses in the area;

Broad land use category	Target
Creative and KIBS	At least 10%
Retail and services	Between 15% and 20%
Residential	Between 30% and 35%
Other uses including commercial, education, boutique hotel, social and civic uses, or, additional	
creative and KIBS and/or residential use:	The remainder


Urban Form Masterplan

- Pattern of urban perimeter blocks

- reflects the character of the city centre of Kilkenny.
- Activity to the street or space
- Allows clear definition between public spaces and private or semiprivate courtyards
- Allows a mix of use types and sizes




## Sample Block Subdivision

Business of the Partnership:

Does not tie up KCC resources




Overall Planning Framework remains a matter for the Elected Members. No change to the framework / masterplan.



#### Brewhouse Project including Horse Barrack Lane & Brewhouse Courtyard

- Construction commenced on 15<sup>th</sup> July 2019
- Funding sources for Public Realm
  - European Regional Development Fund
  - Urban Regeneration and Development Fund
  - KCC
- <u>Programme</u>
  - Works suspended due to Covid-19- now recommenced
  - Completion expect March 2021.


















## **Background to Mayfair Building**

- Constructed in 1943
- Mayfair Ballroom from 1943 to 1973



- Most recently used by Diageo for Offices / Welfare Facilities
- Abbey Quarter Masterplan allows for the retention and renovation of the building.-Strong social heritage
- Part VIII Planning Consent in July 2019 to renovate the Building for Library Use
















#### **Riverside Garden Project**
